

RESOLUTION NO. 23-05

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE
CITY OF BANDON, OREGON, PLACING ON THE MAY 16, 2023
ELECTION BALLOT A MEASURE AUTHORIZING AN INCREASE IN ELECTRIC RATES.

WHEREAS, Electric rates for the City of Bandon ("City") Electric Utility are insufficient to pay for proper operation and maintenance of the Electric system, and to build reserves for future Electric system improvements; and

WHEREAS, the City Charter restricts the ability of the Mayor and City Council to set Electric rates, except by consent of the voters; and

WHEREAS, the Mayor and City Council believe that the attached schedule of rates provides sufficient revenue and an appropriate balance of rates.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Bandon that the measure captioned "City of Bandon Electric Rate Increase," which is included herein as Exhibit A, is hereby placed on the May 16, 2023, election ballot for the City of Bandon; and

BE IT FURTHER RESOLVED that upon approval by the voters, the City will implement the Electric rates set forth in Exhibit B.


BE IT FURTHER RESOLVED that this resolution shall become effective upon its adoption and approval.

CAPTION: City of Bandon Electric Rate Increase

QUESTION: Should the City increase Electric rates for operations and maintenance?

SUMMARY: This measure increases Bandon's electric rates by 1.2 cents per kilowatt hour. The measure also increases the various base charges by \$5.00 per month for in-city customers, and \$10.00 per month for customers outside the city.
