#### **BACKGROUND:**

This is the second of two (2) work sessions held before the City Council on the FY 2024-25 Budget. The objective of this work session is to establish five (5) priority goals that will guide the preparation of the upcoming budget. Preparing a budget that aligns with the budgetary goals of the City Council helps ensure that funding is appropriated in a manner that meets the priority needs of the community. Establishing the City's priority goals for the upcoming fiscal year is often the result of a comprehensive strategic planning process. Due to time constraints, the process has been streamlined with the hopes of obtaining a general sense of the City Council's budget priorities for the upcoming fiscal year.

#### **FUNDING CATEGORIES:**

Funding categories are broad classifications of City services, programs, and activities. Each funding category includes goals for providing City services and programs. The first step in establishing the City's priority goals is to identify the funding categories that require the highest level of attention. While all of the funding categories are significant in their own right, it is recommended, and considered an industry best practice, to identify five (5) priority categories. A focused list of funding categories will help to establish the City's five (5) priority goals for the upcoming budget year. The attachment titled "Funding Categories and Goals", contains a list of funding categories along with their related goals for prioritization.

It is requested that each City Council member review the funding categories and present their respective top five (5) funding categories to City staff at the beginning of the budget work session. Staff will compile this information and present a list of the top five (5) funding categories selected. Once the top five (5) funding categories are identified, the City Council will be asked to choose the top five (5) goals from the funding categories by consensus.

#### GOALS:

Priority goals are essential for addressing the most significant issues facing the City. Goals can include items such as reducing vehicle speeds in residential areas, revitalizing Old Town, growing local tourism, increasing workforce housing stock, and protecting local land use control. Goals should be ambitious yet reasonably attainable, while also being instructive for the benefit of the City employees who will be responsible for their implementation. As with funding categories, goals should be limited to no more than five (5). Limiting goals to five (5) helps ensure that they are attainable and do not excessively strain existing staffing and financial resources. The top five (5) goals will be placed in priority order, serving to guide the allocation of funding in the FY 2024-25 Budget.

To assist in ranking the City's top five (5) priority goals, an attachment containing a preliminary list of goals has been provided for City Council reference and consideration (see Attachment – Priority Categories and Goals). The list of goals is based on previous City Council discussions and public comments received over the past year.

#### CONCLUSION:

Establishing priority goals for the upcoming fiscal year is essential to ensure the development of a financially sound and responsible budget that allocates funds in accordance with the City Council's priorities. The direction and progress made towards achieving these will prove to be instrumental in sustaining a healthy and robust local economy.

#### **RECOMMENDATIONS:**

City staff recommends the following to the City Council:

- Review and discuss the information provided;
- Identify five (5) priority goals to guide the preparation of the City's preliminary FY 2024-25 Budget;
- 3. Direct the City Manager or designee to prepare the City's preliminary FY 2024-25 Budget in alignment with the priority goals established by the City Council; and,
- 4. Present the City's preliminary FY 2024-25 Budget to the Budget Committee for review and consideration at its meeting scheduled for April 15, 2024.
