The applicant must post the grading-fill permit on the premises for the duration of the work approved. 3. The project cannot begin until after the approval date shown on this form. 4. It is the applicant's responsibility to notify all utilities and request locates prior to digging or grading. 5. Grading and filling using heavy equipment shall be limited to the hours between 7:00 a.m. and 7:00 p.m. 6. Existing grade, and proposed/finished grade, will be illustrated on an attached plan. 7. The direction of all drainage will be illustrated on the attached plan. 8. No application will be processed without existing and proposed grade and drainage illustrations. 9. The property owner will be responsible for all costs associated with the proposed project. 10. All property corners must be accurately staked and visible prior to commencement of any activity and remain after completion of work. 11. When required by the City pursuant to the provisions of Chapter 70 of the Appendix to the 1991 edition of the Uniform Building Code published by the International Conference of Building Officials, grading, fill, and / or drainage plans shall be prepared by an engineer currently registered in the State of Oregon. 12. The granting of this permit does not presume to give authority to violate or cancel the provisions of any State or Federal law regulating this activity. It is the property owners' responsibility to ensure compliance with those agencies.
