This notice is provided to you in order to comply with ORS 227.186 which requires the City to print the following information:

## THIS IS TO NOTIFY YOU THAT THE CITY OF BANDON HAS PROPOSED A LAND USE REGULATION THAT MAY AFFECT THE PERMISSIBLE USES OF YOUR PROPERTY AND OTHER PROPERTIES.

The Planning Commission of the City of Bandon will hold a public hearing on April 30, 2015, at 7:00 P.M., in the City Council Chambers of the City Hall, 555 Highway 101, Bandon, Oregon, regarding the adoption of an ordinance amending Chapter 16.42 – Definitions, and Title 17 - Chapters 17.44, 17.52, 17.92, and 17.96 of the Bandon Municipal Code. The proposed ordinance would amend regulations regarding medical marijuana facilities (MMF). The City of Bandon has determined that adoption of this ordinance may affect the permissible uses of your property, and other properties in the affected zone, and may change the value of your property.

The proposed ordinance would amend the Bandon Municipal Code and all for medical marijuana facilities (MMF). The proposed amendments would allow MMF's within the C-2 and LI Zones, except those zones that are located within 1000 linear feet of a school property. Changes to the proposed regulations may be made at or following the public hearing.

Time will be allowed for verbal testimony at the hearing. It is also recommended that testimony be presented in written form. You may also submit testimony by US mail or electronically.

Please note the deadlines below for submitting testimony:

- 5:00 pm, April 22, 2015: Deadline for inclusion of testimony in Planning Commission packet.
- 5:00 pm, April 28, 2015: Deadline for Electronic (e-mail or FAX) testimony. PLEASE NOTE: Every effort will be made to deliver your electronic message to the commission. However, the City of Bandon is not responsible for failure of communications links, hardware or software in delivery of your testimony. In no event can the City ensure your electronic testimony will be given to the Commission unless it is electronically or physically received before 5 p.m. on April 30, 2015.
- 5:00 pm, April 30, 2015: Deadline for receipt of hand delivered or US mail testimony.
- After 5:00 pm on April 30, 2015: Testimony must be presented at the hearing.

The failure of an issue to be raised in this hearing in person or by letter, or failure to provide sufficient specificity to afford the decision maker an opportunity to respond to the issue precludes appeal to the City Council/Land Use Board of Appeals based on that issue.
